4. Applications to register to vote must reach the Electoral Registration Officer by **12 midnight on Friday 12 April 2019**. Applications can be made online: **<https://www.gov.uk/register-to-vote>**.
5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Room F7, Council House, Avenue Road, Malvern, Worcestershire, WR14 3AF by **5 pm on Monday, 15th April 2019**.
6. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Room F7, Council House, Avenue Road, Malvern, Worcestershire, WR14 3AF by **5 pm on Wednesday, 24th April 2019**.
7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Room F7, Council House, Avenue Road, Malvern, Worcestershire, WR14 3AF by **5 pm on Thursday, 2nd May 2019**. The physical incapacity must have occurred **after 5 pm on Wednesday, 24th April 2019**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person **after 5 pm on Wednesday, 24th April 2019**.
